#### General Purpose

The MEAL Officer oversees monitoring and evaluation activities for the organization's projects, conducting surveys, and ensuring data collection integrity through site visits. They collaborate with the MEAL department, develop tracking tables, and design tools for project activities. The officer analyzes and reports monitoring data, facilitates information sharing with stakeholders, and contributes to program development by sharing lessons learned.

Throughout the intervention, the MEAL Officer will work towards ensuring quality delivery of all project activities with support from the Project Manager and MEAL department. As part of an experienced project team, you will help coordinate the proper implementation of all project activities through the duties outlined below.

### Responsibilities

#### Main Responsibilities

- ☐ Conduct surveys, ensuring appropriate sample size and sampling survey methods, data collection procedures, and data verification through periodic site visits.
- ☐ Collect qualitative and quantitative information on program data through assessments, post-distribution monitoring, and regular market monitoring.
- ☐ Work with the MEAL department to develop and complete the monthly Indicator Performance Tracking Table (IPTT).
- ☐ Assist program teams in the selection of beneficiaries as per the established procedure.
- ☐ Develop relevant MEAL tools for project activities
- ☐ Facilitate training of staff and Community Mobilizers in M&E data collection tools and participate in the sensitization of beneficiaries in collaboration with program teams.
- ☐ Support in collating, and analyzing monitoring data, as well as reporting on findings from monitoring activities.
- ☐ Quantify methods and identify data sources for program performance and impact indicators, in conjunction with the project team. Provide support to the programs within the communities.
